Expenditures (hard and soft costs) for the first group of projects in Phase 2a total <u>\$164,367,655.79</u> Expenditures (hard and soft costs) for the second group of projects in Phase 2b total <u>\$138,631,674.87</u> Expenditures (hard and soft costs) for the third group of projects in Phase 2c total <u>\$113,988,128.14</u> Expenditures (soft costs) for the fourth and final project for Phase 2d total of <u>\$24,502,261.73</u> Total amounts paid to date for all Phase 2 projects total <u>\$441,489,720.52</u> of the \$435M borrowing limit and the approximately \$16M of supplemental funds (i.e., SSBA, CSG, NYSERDA Rebate, RG&E Rebate).

- Overall Workforce (EEO) Participation: Minority @ 26.76% (goal is 22%) and Women @ 6.43% (goal is 8%).
- Overall Workforce (EEO) Participation: Minority Males @ 23.20% (goal is 22%) and Women @ 9.99% (goal is 8%).

- Overall Business Participation: Minority @ 19.07% (goal is 17%), Women @ 11.80% (goal is 10%), Small @ 2.52% (goal is 3%) and Disadvantaged @ 2.61% (goal is 3%).

- Rochester Residents: 3 of the 19 workers for the September 2021 reporting period (or 15.79%).
