Resolution 2023-24:30 Phase 3A and 3B Architect RFPs

WHEREAS, the Rochester School Facilities Modernization Program Act (the "Act") established the Rochester Joint Schools Construction Board ("RJSCB" or "Board"), a seven voting member board consisting of equal representation by the City of Rochester ("City") and the Rochester City School District ("District"), as well as a member jointly selected by the City and the District; and

WHEREAS, under the Act, the RJSCB has certain enumerated powers to act as agent for the District, the City, or both; and

WHEREAS, the New York State Legislature amended the Act by enacting Chapter 533 of the Laws of 2014 ("Amended Act"), thereby providing alternative financing mechanisms for the reconstruction of up to 26 projects for a total cost of \$435,000,000 for Phase II; and

WHEREAS, the New York State Legislature amended the Amended Act by enacting Chapter 614 of the Laws of 2021 ("Second Amended Act") to authorize additional oversight, transparency, and accountability by the New York State Education Department to ensure projects are completed on time and within budget, and to provide alternative financing mechanisms for the reconstruction of up to 12 projects for a total cost of \$475,000,000 for Phase III; and

WHEREAS, the RCSD has identified and confirmed the projects for Phase 3 of the RSMP for which the RSJCB has started planning work in advance of the approval of the comprehensive Master Plan for Phase 3; and

WHEREAS, these identified projects (the "Phase 3A and 3B Projects") include: Dr. Martin Luther King, Jr. School 9; Joseph C. Wilson Magnet High School Commencement Academy; and Franklin Educational Campus; and

WHEREAS, the RJSCB's Phase 3 Program Manager has prepared a request for proposals for Design Services for Phase 3A and 3B Projects (the "RFP"), provided the draft of the RFP to the RJSCB for review, and it is ready to be issued; and

WHEREAS, the Chair and Phase 3 Program Manager have recommended that the RJSCB approve the issuance of the RFP; and

WHEREAS, the RJSCB discussed and considered the RFP and the recommendations at its regular monthly Board meeting on April 9, 2024, and now acts as follows.

THEREFORE, BE IT RESOLVED:

- 1. The RJSCB hereby approves the RFP for Phase 3A and 3B Design Services and authorizes the Program Manager to issue the RFP on April 10, 2024; and
- The MWBE and Services Procurement Committee is authorized, on behalf of the RJSCB, with the
 advice and recommendations of the Program Manager, to review the Phase 3A and 3B RFP
 responses, select finalists, conduct interviews of the design services finalists along with other
 RJSCB board members, and recommend to the RJSCB the most qualified candidates
